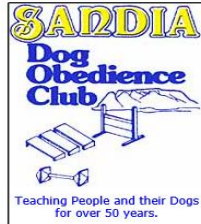

AVMA STATEMENT

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. You should always have a copy of your rabies vaccination certificate with you when you travel with your dog

SPECIAL COVID STATEMENT

- **SDOC will be following all current New Mexico state mandates and CDC guidelines regarding the wearing of masks and other COVID precautions.** All New Mexico State COVID public health orders that are in effect on the trial dates will be enforced. Refer to the NM Department of Health's website at <https://cv.nmhealth.org/> for more information. As of the publication of this premium, NMDOH guidelines require everybody to properly wear a mask indoors regardless of vaccination status.
- **AKC's Suggested Best Practices** will be followed as current conditions dictate.
- **In the event that these trials are cancelled** due to changing COVID conditions, exhibitors will receive a full refund of their entry fees.
- **Exhibitors who develop COVID symptoms** and/or have an exposure/positive test after the closing date should withdraw and will receive a full refund of their entry fees for any unused class entries.
- **Failure to comply** with any of these measures may result in a committee hearing, and/or immediate ejection from the trial, with no refund of fees.
- **By entering these trials**, exhibitors agree to all of the above requirements and precautions.
- Crating is to be in cars or limited crating available on agility field under cover. Indoor crating available for volunteers only.
- **The next two exhibitors** will be allowed in the training room to warm up and watch before it is their turn. Otherwise no spectators allowed at these trials.

NOTICE TO EXHIBITORS - RALLY TRIAL RULES

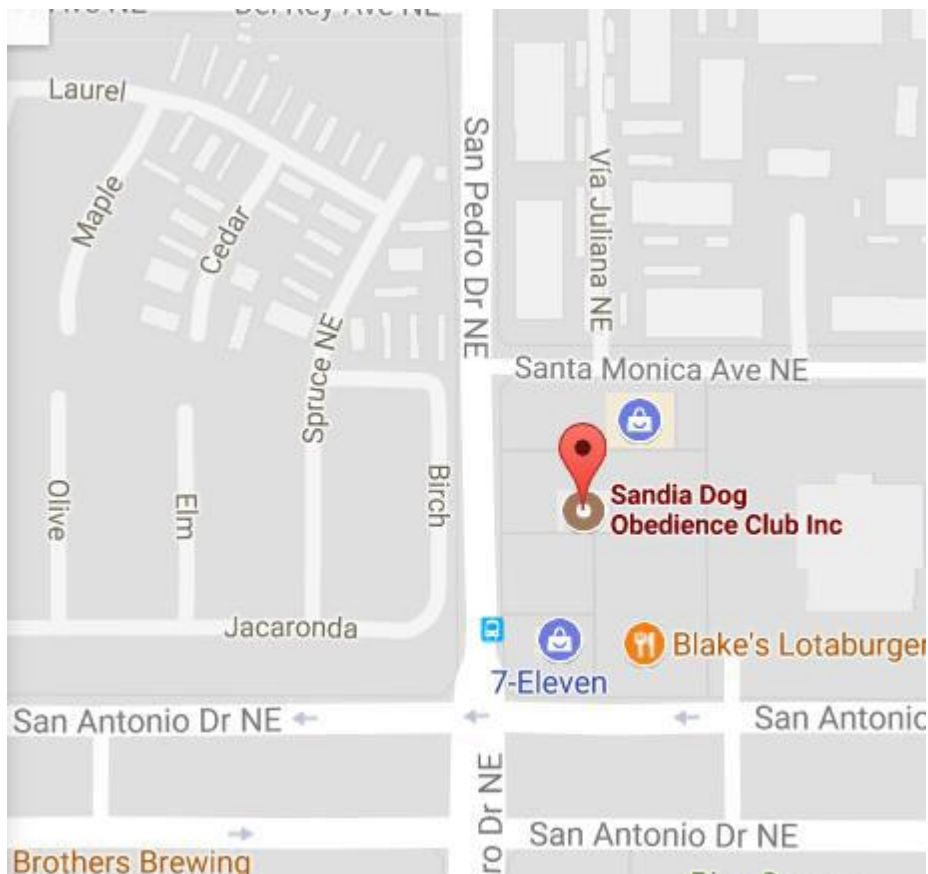
1. Fees must accompany entries. Sandia Dog Obedience Club assumes no responsibility for incomplete or inaccurate information on the entry form or for a dog being entered in a class for which it is not eligible.
2. Entries must be on an official American Kennel Club entry form. Conditional, unsigned, incomplete, telephone, facsimile or emailed entries will not be accepted.
3. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee
4. Entry fees will be refunded for bitches that come into season after the closing date of the trial. The trial secretary must be notified no later than one half hour prior to the start of the first class in the trial for the fees to be refunded.
5. All entries must be addressed to the Trial Secretary's address. Priority and Express mail must be sent with a **waiver of signature requirements**. **No hand delivered entries will be accepted in the first 24 hours after trial opens.** Hand delivered entries will thereafter be accepted at show secretary's address in locked drop box on post across from front door.
6. Acknowledgement of entry received will be sent to the email address listed on the entry form, provided that said address is legible. All final confirmations and Judging Programs will also be sent via email.
7. The Trial Committee may decline any entry for cause or may remove any dog on account of sickness or other cause and no one shall have any claim or recourse against Sandia Dog Obedience Club or any official thereof, nor the Trial Secretary
8. Sandia Dog Obedience Club is not responsible for the loss or damage to any dog exhibited, whether it results from an accident or other cause. It is to be clearly understood that every dog at this trial is in the care, custody and control of the owner or his/her agent at all times.
9. Dogs need be present only for scheduled judging and will be released if not needed for further judging
10. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring at the appropriate time. It is not the responsibility of the ring steward or any other officer or agent of the club to locate any dog for judging
11. Class placement ribbons and prizes will be awarded in the judging ring to the person exhibiting the dog, who will be considered to be the owner or agent of the owner. Prizes awarded for competition between classes will be awarded after completion of judging all classes at the trial. All prizes must be picked up the day of the trial; none will be mailed.
12. In the event of a tie score for any award, it will be the responsibility of the handler to have the dog available for a runoff. Any dog not present for the runoff forfeits its right to the award.
13. The Trial Committee reserves the right to cancel the trial in the event of extreme weather conditions as per AKC directive dated July 23, 1995.
14. Members and officers of SDOC, committee members, and the Trial Secretary, as well as their family members will be allowed to show dogs at these trials.
15. An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test. All Recording and Event Service Fees are paid to the American Kennel Club. These fees are included in the Entry Fee.
16. A withdrawal from the trial after the closing date due to an injury or illness to the dog will be eligible for a refund up to 75% of the total entry fee paid. A veterinarian's note will be required for the refund to be issued.
17. All Obedience classes will be run in jump-height order.
Saturday – Short to Tall Sunday – Tall to Short

ALL EXHIBITORS ARE EXPECTED TO CLEAN UP AFTER THEIR DOGS AT THIS TRIAL SITE. THOSE FAILING TO DO SO WILL BE SUBJECT TO OFFICIAL ACTION THERE IS A DESIGNATED POTTY YARD OUTSIDE OF THE BUILDING

INSTRUCTIONS

- 1.(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
3.A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
